

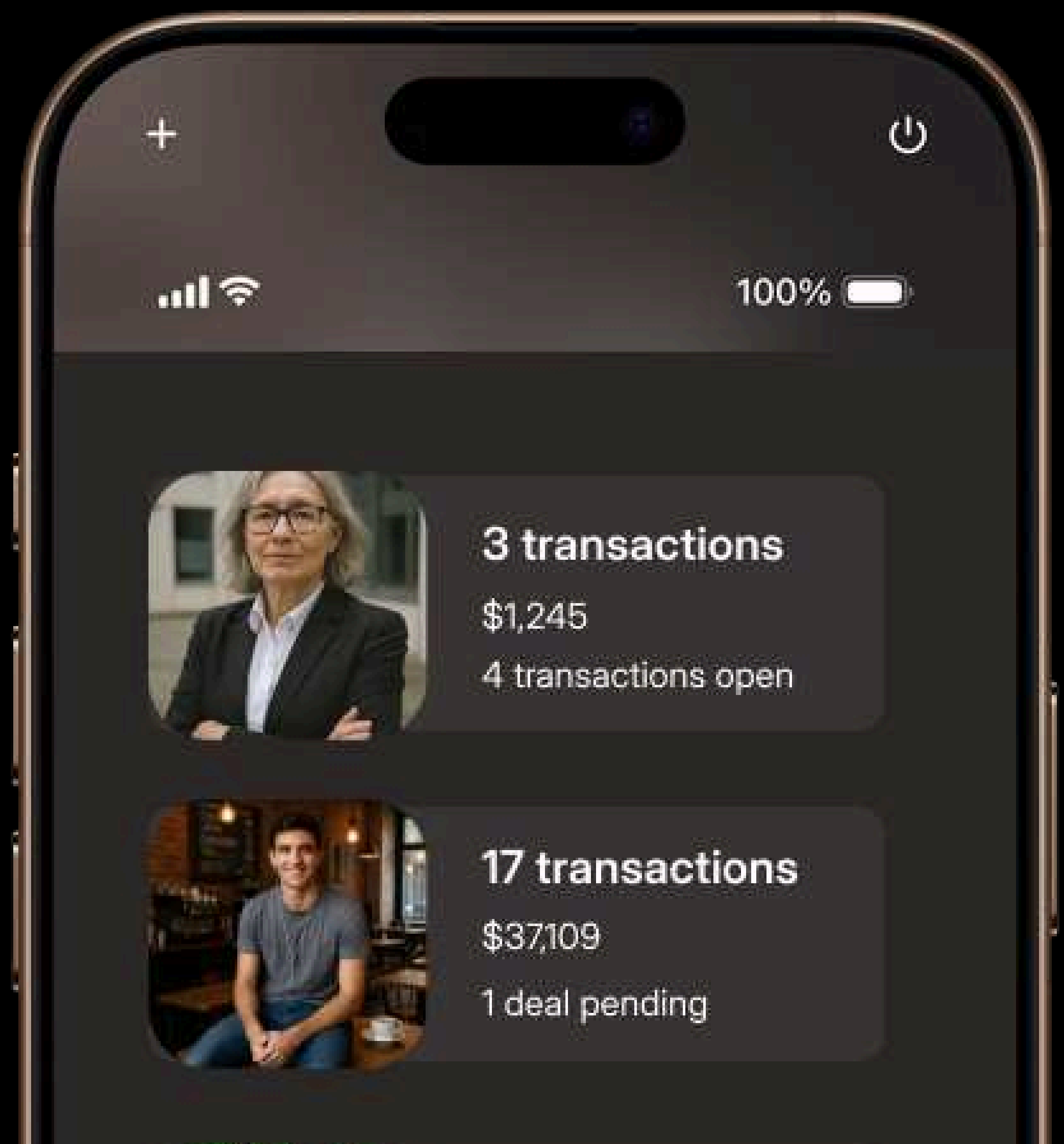

Transactional Model vs. Ownership Model

Traditional Team Model

- Sell → Reset → Repeat

- Scalable recruiting upside
- Business runs without daily management

The Bottom Line:

What Actually Changes

A Different Structure Changes Everything

Instead of:

More deals = more stress

You get:

More alignment = more leverage

How?

- Lower fixed overhead
- No monthly brokerage fees
- Simple cap structure
- Public company stock awards
- Revenue share without managing agents

Less pressure. **More margin. More optionality.**

The Simple Math For You

For The Team Leader

- **85/15 split**
- \$12,000 cap (then keep 100%)
- **No monthly fees**
- \$750 annual fee
- Stock awards at Elite
- **Revenue share upside**
- Optional additional stock via Real Academy

Team Leaders: High producers often **offset most fees through stock + incentives.**

The Simple Math Your Team

For Your Agents

- 85/15 split
- \$6,000 cap (then keep 100%)
- **No monthly fees**
- Annual stock awards
- Simple economics

Why this Matters:

You recruit better agents.
You retain top performers.
They build wealth alongside you.

The **Leverage** Layer

Right now your income likely looks like:
